The Chairman of the committee, present welcome address for the Internal Complaint Committee members.










No sexual harassment complaints were received in the term from the female as well as male students and staff.





The minutes of the earlier meeting were read by the convener and it approved by the Chairman of the committee.


The convener of the ICC committee explained about various activities related to awareness about prevention, prohibition and redressal of sexual harassment.
