Descriptive activities Report:

The college conducts a Workshop on Intellectual Property Rights every year and invites experts in the field. The Department of Life Science, Computer Science, and Library & Information Science jointly organized the IPR workshop for the year 2022.

70 participants, out of them 20 were the teachers from the different colleges of the vicinity, attended the Workshop.

Dr. Sudhir Jagtap, president Swami Vivekanand Shikshan Prasarak Mandal, Udgir District Latur, Maharashtra, inaugurated the IPR workshop and delivered a keynote address. Protection of IPR and its commercialization propagates innovative culture, profitability, market leadership and helps creation of wealth for the individual and eventually the Nation. For that IPR awareness is required which is significant for fruitful growth of the Intellectual property rights (IPRs).

Session 1:

After the short break, the first session started.

Dr. Umakant Patil, Academic Director SVSPM, discussed IPR-Tool to protect Inventions and Creations. He discussed different aspects of Intellectual Properties like what is Patents, Patent Rights, Trademarks, Industrial Design, and Geographical Indication, IC Layout (Semiconductor, Trade Secret, Copyright, and Protection of plant varieties, Farmers' Rights, and Researchers' Rights. Dr. Umakant Patil emphasized that IPR must be renewed from time to time to keep them enforced except in case of copyright and trade secrets. He gave ample examples and made his talk much more informative and exciting.

Session 2:

Dr. Gopal Pawar, principal SVCOE, Udgir, talked about Copyrights and Trademarks, a case study in the session.

He focused on various aspects of copyright and discussed topics like ‘What is copyright?’, ‘What do we mean by author or creator?’ The originality of Literary works, Judicial decisions (Copyright in judgments produced by courts vs. government), etc.

After the lunch break, Dr. D. S. Gond started the session and delivered his lecture on Patent filing procedures and Case Studies.

He explained basic concepts like patents and gave various examples of patents in Life Science and education.
