WHEREAS both Parties wish to enable cooperation and exchange in English language only.



PROPOSED ACTIVITIES PURSUANT TO THE MOU

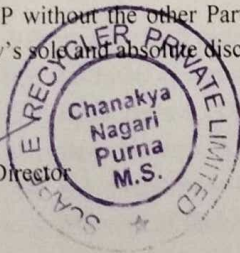

DISPUTE RESOLUTION


